2018 Meeting Minutes

Agenda:

- 1. Call to Order JDV called meeting to order at 0900
- 2. Minutes of the 2017 OBRC AGM: No comments/changes arising. Josh: motion to approve. Vote: 7-0 in favour.
- 3. Business arising from 2017 AGM:
 - a. No issues carried forward from 2017 AGM
- 4. Third round voting: discussion
 - a. 2018-021 Eurasian Collared-Dove
 - i. Consensus appears to be suspect; regularly kept in captivity. People heard the birds; species could have been present for a while. None looked like African Collared-Dove. Species is rapidly expanding, may be colonizing the province now. Eastern forests appear to have slowed their spread to Ontario. Vote: 6-1.
 - b. 2018-023 Eurasian Collared-Dove
 - Looks close to 'normal' looking EUCD. Looks similar to birds in Florida.
 Vote: 7-0
 - c. 2018-028 Eurasian Collared-Dove
 - Looks good, minus the under-tail web-patterning, which is highly variable.
 Vote: 7-0
 - d. 2019-029 Eurasian Collared-Dove
 - i. Only one photo; but nothing at odds with the ID. Vote: 7-0
 - e. 2019-030 Eurasian Collared Dove
 - Pale wing colouring but within range of variation. Location is suggestive of a 'good' vagrant. Vote: 6-1
 - f. 2018-032 Eurasian Wigeon
 - i. Originally voted no and is maintaining that there is no description noted; unsure of how you could accept this record. Likely a EUWI but not enough details. BNC: no notes taken on the bird; there is no description. Evidence provided is moot. PP: don't doubt the identification, just no details provided. Vote: 0-7
 - g. 2018-071 Townsend's Warbler
 - JDV: overview of voting. Description sounds compelling. DAS: sketch is not very good. Not enough details to support identification. WGL: could be a good record but not enough details. Vote: 2-5
 - h. 2018-073 Western Sandpiper (Mitchell)

- i. JDV: overview of voting. Species has a long migration window of observations in Ontario. DAS: strong written description to make case for ID of species is very challenging. Over-reported species in Ontario. PP: very rare in Ontario. Long-billed female SESA's can be. WGL: description is not a SESA. WRSA? Are people hung-up on size? BAM: been tripped up on SESAs before: Vote: 2-5
- i. 2018-074 Western Sandpiper (Blenheim)
 - DAS: outside export opinion supports SESA. BAM: observer was not entirely sure of identification. JDV: WESA have much earlier pre-basic moult; bird should be in basic plumage. Vote: 0-7
- j. 2018-139 Eastern Willet
 - i. BNC: not enough information known on sub-species identification. Brandon Holden agreed with P. Burke's overview that subspecies should have morphometrics and voice taken. Outside expert opinion was not supportive of Eastern claim. JDV: very interesting looking bird. DAS will look at records of Eastern Willet and solicit more information from outside expert opinions and provide information to Committee for potentially resubmitting. Vote: 2-5
- 5. Member motion to re-review records:
 - a. 2018-080 Wood Stork
 - i. Motion put forward by JDV to review the record.
 - ii. JDV: would constitute only the second spring record for Ontario. Did not adequately eliminate AWPE; only thoughts are tail. For a rarity of this magnitude, there is very little supporting documentation. WGL: bird was very close to observer.
 - iii. Vote to be re-reviewed for next year: 7-0. Motion passed. Record will be re-reviewed by 2019 committee.
 - b. 2018-048 Swallow-tailed Kite
 - i. PDP proposed record for review.
 - ii. PDP: doesn't think record is adequately documented.
 - iii. DAS: details of the observation aren't supportive/great.
 - iv. Vote to be re-reviewed for next year: 5-1-1 (WGL voted no, BNC abstained). Motion passed. Record will be re-reviewed by 2019 committee.
- 6. Motions to add/remove species from South Review list:
 - a. Ken: motion to remove Eurasian Collared-Dove
 - KGB: presented list of 23 accepted records (plus 3 unreviewed, 3 insufficient evidence) in the past five years. Noted that of the 3 insufficient evidence, 2 would now pass on updated thinking on the species.
 - ii. Meets threshold of OBRC's guideline (20 in five years). 23 records accepted by OBRC over past 5 years.
 - iii. Vote: 8-0 in favour of removing. Motion passed.
 - b. Ken: motion to remove White-winged Dove

- i. KGB: presented list of 18 accepted records (plus 4 unreviewed) in the past five years.
- ii. Meets threshold of OBRC's guideline (20 in five years).
- iii. Still a very rare bird, however, one of the species showing the clearest trend of increasing vagrancy in southern Ontario (44 of 47 in southern Ontario have been since year 2000.
- iv. Must take into account that the returning Rondeau bird counts as a separate record each year.
- v. Vote: 5-3 in favour of removing (WGL, DAS, and ?? voted no). Motion passed.
- 7. Motions to add/remove species from Central Review List:
 - a. Ken: motion to remove Eurasian Collared-Dove
 - i. KGB: Presented list of 10 accepted records in the past five years.
 - Meets threshold for removal according to OBRC bylaws (10 records in past five years).
 - iii. Common adjacent to northwestern Ontario.
 - iv. Vote: 8-0 in favour of removing. Motion passed.
 - b. Ken: motion to remove White-winged Dove
 - i. KGB: Presented list of 12 accepted (plus 2 unreviewed) records in the past five years.
 - ii. Meets guideline for removal for Central (10 records in past five years).
 - iii. Quite amazing that the species is showing up so regularly, especially when one considers observer effort.
 - iv. Vote: 8-0 in favour of removing. Motion passed.
 - c. Ken: motion to remove Willet
 - i. KGB: Presented list of 7 accepted (plus 3 unreviewed) records in the past five years.
 - ii. Meets guideline for removal for Central (10 records in past five years).
 - iii. Common adjacent to this review zone (especially in adjacent Minnesota/Manitoba).
 - iv. Vote: 1-7 in favour of removing (MVB voted yes). Motion failed.
- 8. Updates to Bylaws: Mike proposed changing some of the text in the bylaws
 - a. Overview of the roles of Secretary, Chair, Members, as well as possible new position as Archivist:
 - b. Proposed changes to voting members duties (Section 3.3.4), per MVAB tracked changes (within the Bylaws):
 - 1. 3.3.4 Duties:
 - 2. 3.3.4.1 Vote on all records within the timelines agreed upon by the Secretary and Chair,
 - 3. 3.3.4.2 Gather background information/expert outside opinion for records under the direction of the Secretary or Chair
 - 4. 3.3.4.3 Complete other tasks, as assigned by the Chair
 - ii. Motion to accept: 7-0. Amendments passed.

- c. Proposed changes to the Secretary Duties (Section 3.5.4), per MVAB tracked changes (within the Bylaws)
 - 1. [remove] 3.4.4.8
 - 2. [add] new 3.4.4.8
 - a. Prepare annual report with input from all other Committee members
 - ii. Motion to accept: 7-0. Amendments passed.
- d. Proposed changes to Chair Duties (Section 3.5.4), per MVAB tracked changes (within the Bylaws)
 - i. Motion to accept: 7-0. Amendments passed.
- e. Proposed new position: Archivist (Section 3.7), per MVAB tracked changes (within the Bylaws)
 - i. Caveat that the position does not have to be filled every year
 - 1. Wording to include:
 - a. "In the absence of this position being filled, the duties of the Archivist will fall to the Secretary and/or Chair." [line 3.7.3.5]
 - ii. Motion to accept: 7-0. Amendments passed.
